Election to the Executive Committee of All India Football Federation 2022

(Football House, Sector 19, Phase 1, Dwarka, New Delhi - 110075)

Dated 13th August 2022

NOTIFICATION

WHEREAS, the Hon'ble Supreme Court of India in its order dated 3rd August 2022, in Special Leave to Appeal (C) Nos.30748-30749/2017 has provided a timeline on the proposal of the Committee of the Administrators (the "CoA") for holding the elections to the posts of Office Bearers of the All India Football Federation (the "AIFF"). The elections of the AIFF shall be conducted as set out below:

1) ELECTORAL COLLEGE

- (a) AIFF has prepared and shared with the Returning Officer, a consolidated list of Eminent players on 12th August 2022;
- (b) Member Associations have selected their representatives and sent the same to the Returning Officer on 12th August 2022;
- (c) The Returning Officer shall scrutinize and prepare the final List of Voters (comprising State Associations' and Eminent Players' representatives as indicated above) forming the Electoral College in **Form 1**, on 13th August 2022. The Returning Officer will take up objections raised, if any, on the Electoral College, on 14th August 2022 and decide on the same by 10.00 AM on 16th August 2022 (the said period has been extended by one day as 15th August is a National Holiday).
- (d) The Returning Officer shall publish all decisions taken on any objections raised which shall be final and binding. The concerned Member Association shall have the right to file a replacement nomination by 1.00 PM on 16th August 2022. In so far as the Eminent Players are concerned, should there be an objection to their non-inclusion into the Electoral College, the same should be supported with cogent evidence/documents which shall deem them to form a part of the Electoral College. Said objections must also be filed on 14th August 2022. Any decision on such objections taken by the Returning Officer shall be final and binding.
- (e) The amended Electoral College shall be published by 2.00 PM on 16th August 2022.
- (f) The Returning Officer will take up objections raised, if any, on the amended Electoral College, till 5.00 PM on 16th August 2022 whereafter the Electoral College will be published and deemed final. Should such objections be held valid by the Returning Officer, no further replacement shall be provided to the concerned Member Association.



2) NOMINATION OF CANDIDATES

- (a) The Nomination Paper (Form 2) proposing and seconding a candidate to any post of an Office Bearer shall be delivered to the Returning Officer either by post or in person by the candidate himself/herself only between 11.00 AM and 1.00 PM of each day from 17th August 2022 to 19th August 2022.
- (b) Along with the Nomination Paper, each prospective candidate will be required to file an attested copy of any identity document issued by the Government, having the photograph and signature of the candidate. The same must be filed for the Proposer and Seconder as well.
- (c) As soon as may be after 1.00 PM on 20th August 2022, the Returning Officer shall prepare a list of all nominations received by him, post-wise, in Form 3; and publish the same in a conspicuous place in his office and also on the website of the AIFF.

3) SCRUTINY OF NOMINATIONS

The Returning Officer shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise, at 11.00 AM on 21st August 2022.

4) <u>WITHDRAWAL OF NOMINATIONS</u>

Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, between 22nd August 2022 and until 1.00 PM on 24th August 2022.

5) LIST OF CONTESTING CANDIDATES

As soon as may be after 11:00 AM on 25th August 2022, the Returning Officer shall prepare the final list of contesting candidates in Form 6 and display a copy of the said list in a conspicuous place in his office and on the AIFF website.

A copy of the same shall also be furnished to each of the candidates/ their authorised representatives if so demanded.

6) THE POLL

On 28th August 2022:

- (a) Where the number of contesting candidates for any post is equal to or lesser than the number of posts, they shall be deemed to have been elected unopposed.
- (b) Where the number of contesting candidates is more than the number of posts, a poll shall be taken post-wise and shall be done between 9.00 AM and 1.00 PM, in the headquarters of the AIFF in New Delhi. Subsequent rounds of voting, if required for any position shall be informed by the undersigned at the time of counting. All members of the Electoral College are required to mandatorily stay at the venue till the conclusion of the elections.



- (c) At the time of voting, each elector will be required to produce any identity document issued by the Government having their photograph and signature, including but not limited to:
 - i) Passport
 - ii) PAN Card
 - iii) Driving Licence or
 - iv) Any other document issued by the Government having their photograph and signature.

7) COUNTING OF VOTES

- (a) Counting of votes will be taken up on 28th August 2022. If a candidate contests for the post of President as well as for the post of Treasurer and /or Member of the Executive Committee and the candidate gets elected as President, he/she shall be deemed ineligible for the remaining posts and his/her name shall not be considered for counting of votes for the post of Treasurer/Member. The same process shall be followed in case a candidate has contested both for the post of Treasurer and Member, wherein he/she shall be deemed ineligible for the post of Member and his/her name shall not be considered for counting of votes for the post of Member.
- (b) Counting of votes for the President will be taken up first.
 - If any contesting candidate secures (more than 50%) of the total valid votes polled for the post of President, he/she will be declared elected. In case none of the candidates secure more than 50% of the valid votes cast for the post of President then, the contesting candidate with the lowest number of votes shall be removed whereafter a second-round of ballot shall commence.
 - This process will continue till at least 1 (one) contesting candidate secures more than 50% of the valid votes polled for the election of the President.
- (c) The counting of votes for the post of Treasurer will be taken up thereafter and whosesoever secures the highest number of valid votes polled will be declared elected.
- (d) Lastly, the counting of votes for the (10) members will be taken up. In the first instance, the five candidates who have secured the maximum number of valid votes cast for these Posts are recorded in Form 11 (i.e., the five Eminent player candidates having secured the maximum votes out of all Eminent Players contesting) shall be deemed to have been elected to these 5 posts. Provided that there must be at least 2 successful women candidates in these 5 posts for Eminent Players, accordingly if there any deficit in the same (i.e., 0 or 1 successful female candidate), then the corresponding number of women candidates having next highest number of valid votes cast shall be deemed to have been elected in place of the successful male candidates having the least number of votes in the top 5 candidates.

Thereafter, the five candidates having secured the maximum number of valid votes cast for these Posts as recorded in Form 10 (i.e., out of all candidates whether Eminent Player or not), after excluding the five Eminent Player candidates elected as above, shall be deemed to have been elected to the remaining 5 posts. In case of a tie arising out of having secured equal number of votes, the winner will be declared by draw of lots.



Whereas, the Returning Officer has received the names of representatives from the Member Associations as well as the list of Eminent Players from the AIFF for the constitution of Electoral College as required under Article 4.3 of the Constitution of AIFF; and

Whereas, the names so received have been scrutinised and are hereby published in Form 1 for information and necessary action, if any, by the members of the General Body of the AIFF.

The Electoral College will be finalized after 5.00 PM on 16th August 2022. The ensuing election and result thereof will be subject to the directions of Para 17 of the order dated 3rd August 2022, of the Hon'ble Supreme Court of India and any further orders of the Hon'ble Supreme Court of India.
