Sub: Appointing office bearers for Tamil Nadu Football Association

- 1.** I am the Secretary of Chennai District Association. This letter relates to appointment of office bearers to Tamil Nadu Football Association (hereinafter referred to as TFA).

- 2.** The tenure of the office Bearers of Executive Committee of TFA who were last elected on 21.09.2014 for a term of 4 years expired on 20.09.2018. The TFA was to duly conduct a General Body Congress/Election on or before 20.09.2018, which was not conducted. They continued to stay in power beyond their tenure which was in violation of the articles 36.3 & 18.3 of the Constitutions of TFA and AIFF.

- 3.** However, Mr. Jesiah Villavarayar, Ex-President of TFA after his term as President expired in 20.09.2018 after a delay of 6 months attempted to call for elections for TFA scheduled on 09.02.2019. Krishnagiri Football Association approached the Hon'ble High Court of Madras and obtained an interim order on 08.02.2019 restraining him from conducting elections. Despite the above interim order the election was conducted on 09.02.2019. The Hon'ble Madras High Court vide its final order dated 27.09.2019 set-aside the election which was conducted on 09.02.2019 and appointed Retd. Justice Mr. A.K. Rajan as Administrator for TFA.

- 4.** Challenging the above order, TFA filed Appeal before Hon'ble Division Bench and on 23.10.2019 the Hon'ble Division Bench passed an order of Status – quo. Therefore, the fact remains that none of the elected office bearers elected in the election which was set-aside as on 27.09.2019 can function.

- 5.** In the meanwhile, Mr. Jesiah Villavarayar attempted to call for an Executive Board Meeting on 17.01.2021. CFA immediately filed O.A Nos. 11 and 12 of 2021 before the Hon'ble Madras High Court and vide order dated 08.01.2021 the Hon'ble Court restrained him from convening of the above meeting and the same was restrained by the Hon'ble High Court as he lacked official powers. In view of all the above orders passed by the Hon'ble Madras High Court as on date, TFA is headless and cannot function in any manner. Football in Tamil Nadu is in doldrums right from the year 2014, the period from which Mr. Jesiah Villavarayar assumed office of TFA.

- 6.** We as a District Association affiliated to TFA through newspaper articles and through other sources reliably learnt about the election for electing office bearers of AIFF. TFA did not conduct Annual General Body meeting for last several years. The District Associations in Tamil Nadu have suffered seriously as the State Body i.e. TFA did not function properly. The defunct TFA cannot function and it is time that the District Bodies unite together to nominate new office bearers for TFA. The development of the game football in the paramount consideration for this step.

7. We further bring to your notice that the TFA was disqualified to vote in the upcoming elections of AIFF. The representation of Tamil Nadu Football Association in the National Body Election is very crucial. As per clause 39.10 of the Model Election Guidelines provided in the National Sports Code, a State Association can be admitted as a member of federation if minimum of 50% of the District Level Association Affiliated to it. At present there are about 28 District Level Association affiliated to TFA. Out of the above 28 District Level Associations, 15 Associations i.e. more than 50% are supporting **Mr. P.Karikalan**, who is the present President of Chennai District Football Association to represent TFA in the upcoming election of the AIFF. Subject: Inclusion in the Electoral College

Sir,

On 22nd August 2022, the Hon. Supreme Court has passed a fresh order in I.A. NO.111940/2022 in Special Leave to Appeal (C) Nos.30748-30749/2017 issuing direction to refix the modalities for the filing of nominations from the stage which was reached on 13 August 2022 and to extend the election by one (1) week. In this regard, an opportunity to file representation or claim to the electoral college prepared on 13 August 2022 was given to all the state and union territories of the football association.

Kindly refer to your email dated 24th August 2022 addressed to the Returning Officer regarding the inclusion of name of Mr. P. Karikalan in the Electoral college as the representative of the Tamil Nadu Football Association (TNFA).

Report regarding the up to date status of TNFA Executive Body was taken from the AIFF. The AIFF has informed that the election held in TNFA has attained finality in light of the order passed by the Hon'ble Madras High Court on 28.06.2022 whereby the suit which gave interim stay on the elections was dismissed for non-prosecution by the Petitioners.

It may further be stated that Article 4.2 of the Draft Constitution provides that the President/ Secretary may nominate their representative to be part of the Electoral College.

The fresh nomination filed by Mr. E. Sugumaran is not acceptable since he is not the General Secretary/President of the Tamil Nadu FA as per the AIFF records and nomination made only by President/General Secretary is to be accepted by RO.

In view of the above, your request has not been accepted.



It may be stated that Article 4.2 of the Draft Constitution provides that the President/ Secretary may nominate their representative to be part of the Electoral College. Nomination of Mr. Lalit Chawdhry was received from General Secretary (Mr. Lalit Chawdhry) of Haryana Football Association and no other nomination was sent to RO by President/General Secretary of Haryana FA during the period of nomination.

The AIFF has informed that as per their records till date Mr. Lalit Chawdhry is the General Secretary of Haryana Football Association and nomination filed by him was admissible as per article 4.2 of the draft Constitution.

The fresh nomination filed by Ms. Shaffali Nagal is not acceptable since she is not the General Secretary/President of the Haryana Football Association as per the AIFF records and nomination made only by President/General Secretary is to be accepted by RO as per Article 4.2 of the draft Constitution.

In view of the above, nomination of Mr. Suraj Pal is not included in the list of Voters/Electoral College.

Sub: Election Notification dated 22.08.2022 - Electoral College for AIFF Elections – Representation for Tamilnadu Football Association (TFA) – Non Inclusion – Reg.

1. TFA is in receipt of the election notification issued by the Returning Officer of AIFF. We are dismayed and shocked to note that TFA represented by its President Mr. JesiahVillavarayari.e. myself, is shown as not included citing the reason "*Appears to be ineligible as per Art. 4.1 Schedule III of the Draft Constitution.*" I am not aware of what records are available with AIFF based on which the above decision has been taken and TFA has not been included in the electoral college. It appears that some vested interests inimical to the interests of TFA are operating with an agenda to prevent TFA from being represented in the elections. This representation is being sent to place on record that there is a validly constituted elected Executive Committee functioning in TFA and that TFA is eligible to participate in the Ensuing AIFF elections.

2. I state that TFA held its elections on 9.02.2019 at a duly convened General Body Meeting. While so, a Suit C.S. No. 126 of 2019 came to be filed purportedly by Pennar Senior FC, Krishnagiri District Football Association along with some clubs before the Madras High Court and an Order of Injunction came to be passed in respect of the election. Since the elections had been completed and Office Bearers had assumed charged even before the Injunction was communicated, the Office Bearers continued carrying on the activities of TFA. Ultimately the Order of Injunction was confirmed, as against which I have preferred Appeals before the Division Bench of the Hon'ble High Court, Madras. By an

Order dated 23.10.2019 in OSA Nos.278 and 281 of 2019, the Hon'ble Division Bench passed an Order admitting the Appeals and directing *Status Quoto* be maintained. By virtue of the Order of *Status Quo* passed, I have continued discharging functions as the President and the Executive Committee has also continued discharging its functions. All the official authorities including AIFF, also continue to recognise me as the President of TFA. **While this is so, by a Judgement dated 28.06.2022, the Suit CS No. 126 of 2019 has been dismissed by the Hon High Court . As a consequence, all Interim Orders passed stand merged with the final Judgement of dismissal of the Suit and are no longer in force. The Copy of the Judgement dismissing the Original Suit is enclosed.** Thus, the elections to TFA are no longer under challenge and there is no embargo in the functioning of the elected office bearers including me representing as the President of TFA.

3. It is to be noted that I have received a proper Notice of the AIFF Congress and attended the same held at Mumbai in February 2022 as the President of TFA. The fact that we have received the Notice of the AIFF Congress establishes that the records of AIFF reflect the existence of Executive Committee of TFA and the fact that I am recognised as its President. I was also a Delegate representing India at the FIFA World Congress held in Qatar. I/TFA have been an active member till now and never been disqualified.

4. It is to be noted that the procedure always followed by AIFF if there is any purported non compliance of the Constitution of AIFF or any other issue in a State Association is to send an appropriate communication in this regard calling for an explanation and thereafter, if issues still remain unresolved, take a decision on disqualification etc., if so warranted. It is to be noted that till date, TFA has not received any Show Cause Notice or any other communication disqualifying it or stating that it is in violation of any provision of the draft constitution. Therefore, any attempt to disqualify TFA now or remove it from the electoral college of AIFF would be in complete violation of Principles of Natural Justice. It appears that some vested interests who have personal enmity with me may be instigating the spread of such false information. The communication now sent will have a serious impact on the activities of TFA and amount to interference with its right to exercise its franchise. The communication is entirely untenable and unsustainable in Law and in violation of Principles of Natural Justice and may also render the elections of AIFF invalid on account of non inclusion of an active member.

In view of the above, I request you to immediately include the name of Tamilnadu Football Association rep by its President Mr. Jesiah Villavarayar in the electoral college for the elections of AIFF and issue an appropriate corrigendum to the election Notification dated 22.08.2022, immediately and oblige.

The Andhra Pradesh Foot Ball Association (Hereinafter referred to as "Association") is an Association registered under the provisions of AP Societies Registration Act, 2001 with Registration bearing No.963/2019 on the file of the Registrar of Societies, Visakhapatnam.

The aims and objectives of the Association are to maintain General Control of Football game, give its decisions in all matters concerning thereof, to promote measures for protection of game and the players, to communicate with public authorities and various sports organizations and to regulate and control Football game among others.

Significantly, the Association consists of General Body and Executive Committee members whose tenure is for a period of 3 years for which the President shall be the Chief Supervision, Constitutional head and the controlling officer and the Secretary shall convene all the meetings, maintain proper records and carry the resolutions of the General Body and Executive Committee into effect. The preceding elections to the Association were held on 22.05.2019 and in accordance with bye-laws, their tenure expired on 21.05.2022.

11.04.2022 at Eluru to discuss about the following agendas: 1) Induction of new clubs obliging restructuring of the Districts in the State of Andhra Pradesh, 2) Administrative Issues pertaining to State Association caused by the ineligibility of the President, 3) Providing affiliation & membership to the newly formed Visakha District Football Alliance and Welfare Association in the State Level Association, 4) Steps to be taken to promote the game of football and to tap talent from grass-root level and 5) New policy guidelines to be adopted, in any, for the development of Association.

In accordance with the Rules, Regulations and Bye-laws of the Association, a General Body Meeting was conducted on 11.04.2022 and 03.05.2022, whereby the Quoram has resolved the following: 1) Induction of New Districts post decision of Government of Andhra Pradesh to restructure existing districts, 2) Dismissal of Sri Kosaraju Gopala Krishna and Sri K.V.R.K. Ravindra Kumar from the post of President and General Secretary due to their ineligibility and temporary appointment of Sri Muni Srinivasa Rao and Sri B.Bhaskar Reddy to the post of President and General Secretary to the Association, 3) Affiliation to Visakha District Football Alliance and Welfare Association (Regd. No.169/2022), Nellore District Football Association, Krishna District Football Association, Guntur District Football Association and East Godavari District Football Association, 4) Conducting regular matches/leagues and 5) Conducting fresh elections on 03.05.2022. Respected Sir,

I, on behalf of the Uttar Pradesh football fraternity, humbly, urge you to once again scrutinize the electoral college prepared by your esteemed office for the election to the executive committee of All India Football Federation 2022.

The inclusion of Uttar Pradesh Football Sangh in the electoral college prepared for the election to the executive committee of All India Football Federation 2022 dated 13.08.2022 is not in consonance with the order of the Hon. Supreme Court dated 3rd and 22nd August 2022. As per the Hon'ble Supreme Court's order, the office of the Returning officer must adhere the election procedure to Art. 26 of the Draft Constitution of AIFF and Scheduled III of the Draft Constitution to conduct the executive committee election.

Art. 4.1 of Schedule III of Draft Constitution provides that if the governing body of the Full members of the AIFF has completed its tenure but where elections have not been conducted and concluded before the AIFF elections, such full member shall render themselves ineligible to constitute a part of the Electoral College for the AIFF election, or to nominate any candidate(s) for the same.

The status of the Executive Committee of UPFS should not be recognized at this stage as there is no legitimate and democratically elected body presently in place. The Hon'ble High Court of Allahabad in a Writ Petition (C) No. 25889 of 2020 filed by UPFS itself held that "*UPFS failed to establish a valid election since 2012*" and it had not submitted any proceedings regarding its elections to the Firms, Chits and Societies of Varanasi under Section 25 (2) of the Society Registration Act 1860. It is pertinent to note that UPFS concealed the aforesaid information from the knowledge of AIFF.

Additionally, the recognition extended to UPFS issued by the Emergency Committee of AIFF dated 20.01.2022 and 27.04.2022 is based on the so-called illegal Election conducted by UPFS dated 12.03.2022. The said election violates various rules under the Draft Constitution of AIFF and therefore challenged before the Hon'ble High Court of Delhi in a Writ Petition (Civil) No. 3632 of 2022. The Hon'ble Court has already issued notice to all the concerned parties and the case is listed for the next hearing on 31.10.2022.

Hence, the representation of UPFS is not tenable as the EC of UPFS is very well covered under Art 4.1 of Schedule III of Draft Constitution, according to which such full member shall render themselves ineligible to constitute a part of the Electoral College for the AIFF election, or to nominate any candidate(s) for the same.

Therefore, it is my humble request to you that the name of the representative nominated by UPFS for the purpose of the Electoral College for the conduct of election of AIFF should not be included in the list of Electors/ Electoral College.

Instead of elections, we had conducted a Special General Body Meeting on 03.05.2022 at Tirupati with more than 90% attendance, and unanimously the then President sri Kosaraju Gopala Krishna, and Secretary Ravindra had been removed from APFA, as per APFA's sub rule b) of 5 of the Rules and Regulations of Memorandum "Of APFA2019, and nominated a new President, Shri. M. Srinivasa Rao Treasurer to APFA and Secretary to Srikakulam Dist. Football Association, Srikakulam, and nominated as APFA Secretary, Shri. B. Bhaskar Reddy, to supervise the day to day activities of APFA. In addition to this, we wanted to implead in the AP High Court with reference to Stay Order Dt. 02.05.2022 to submit the facts on behalf of all 13 District Football Associations.

Further, it is to inform you that the tenure of APFA is 3 (three) years as per sub rule d) of 5 of the Rules and Regulations of the Memorandum of APFA 2019. (Copy obtained under RTI from the Office of the Registrar, Registrations Department, Government of Andhra Pradesh)


which expired on Monday, May 21 st, 2022. We are unable to come to know how he has been managing the validity of the affiliation letter for 4 (four) years from AIFF. No APFA member is aware of how AIFF is given validity for four years, which is answerable to the A.P. High Court, the Indian Olympic Association and the Asian Football Confederation, Kuala Lumpur, Malaysia.

Further, it is to inform you that he never had any Membership in any District Football Association prior to 2019. Therefore, he is not at all eligible for any post in A.P. State Football Association. Though he has been misleading the APFA General Body as well as AIFF from 2019 and he grabbed the post of President as well Secretary Post for his employee (who is working in his firm). Gopala Krishna Kosaraju has also misrepresented the facts before AIFF and AP High Court that he is President for APFA. He used to threaten our all district associations if we question his irregularities or if we disagree his mischievous things. In that cases he unanimously suspended the district associations from APFA to scare the other association. He acts as a monopoly and never took the opinions of the executive body member opinions. The mishap is that everybody must obey his unlawful decisions and activities ,otherwise the body members will be suspended mercilessly.

Our intentions are it is very clear that we are working for the development of Football in our all districts and State by keeping in the view of bright future of the Players.

Our grievance before your good selves as all government agencies and social organizations involved in this matter, requesting for taking Disciplinary action against Mr.Kosaraju GopalaKrishna and not to consider his Nomination if any in AIFF Elections-2022. As right now he is not a President to APFA and any district Associations and also Please REMOVE his Voting right and allocate to our present co-opting President Mr.Muni Srinivasarao and Secretary Mr.B.Bhaskar Reddy in Electoral College of AIFF - Request for observing changes made in Executive body of APFA regarding.
