This Request for Quotation (“**RFQ**”) is being published to enable interested applicants (“**Bidders**”) to participate in the selection process (as defined later in this document) to appoint a Service Provider to provide community engagement activities in host cities of Navi Mumbai, Goa and Bhubaneswar for the FIFA U-17 Women’s World Cup India 2022 (“**Tournament**”)
2. The information contained in this RFQ or subsequently provided to Bidders, whether verbally or in documentary or any other form by or on behalf of the Local Organising Committee for the FIFA U-17 Women’s World Cup India 2022 (“**Authority**”) or any of its employees, consultants or advisers, is provided to Bidders on the terms and conditions set out in this RFQ and such other terms and conditions subject to which such information is or may be provided.
3. This RFQ is not an agreement and is neither an offer nor invitation by the Authority to the prospective Bidders or any other person. The purpose of this RFQ is to provide interested parties with information that may be useful to them in the formulation of their Bid pursuant to this RFQ. This RFQ includes statements, which reflect various assumptions and assessments arrived at by the Authority in relation to the Services. Such assumptions, assessments and statements do not purport to contain all the information that each Bidder may require. This RFQ may not be appropriate for all persons, and it is not possible for the Authority, its employees or consultants or advisers to consider the objectives, expertise and needs of each party who reads or uses this RFQ. ## 1. BACKGROUND

The FIFA U-17 Women's World Cup, is the world championship of association football for female players under the age of 17 organized by Fédération Internationale de Football Association ("FIFA").

## 2. FIFA U-17 WOMEN'S WORLD CUP INDIA 2022

The FIFA U-17 Women's World Cup India 2022 will be the 7th edition of the FIFA U-17 Women's World Cup, the biennial international women's youth football championship contested by top 16 U-17 national teams of the member associations of FIFA. The tournament will be hosted by India and will comprise of 32 matches to be held at three Host Cities. This will be the first FIFA tournament for women hosted by the country.

## 3. OVERVIEW OF REQUEST FOR QUOTATION DOCUMENT

- 3.1. The Local Organising Committee ("**Authority**") for the Tournament, a part of the All India Football Federation ("**AIFF**"), and having its principal office at Football House, Sector 19, Phase 1, Dwarka, New Delhi - 110075 has been entrusted by the by Fédération Internationale de Football Association ("**FIFA**") with the organisation, hosting and staging of the Tournament
- 3.2. The FIFA U-17 Women's World Cup India 2022 is envisaged to have a long lasting influence on Indian football, help spread awareness of initiatives taken to improve and develop the game, advocate for gender equality and increase representation of women in football.
- 3.3. As part of this endeavour, the Authority plans to appoint a Service Provider to provide community engagement activities in the stadiums of host cities of Navi Mumbai, Goa and Bhubaneswar as specified in detail in Section 6 of this RFQ ("Scope of Services"). Through this RFQ, the Authority wishes to initiate the Selection Process for suitable Service Providers registered in India who are competent and eligible for providing the services as per the eligibility criteria mentioned in this RFQ document.
- 3.4. The Authority invites proposals (the "Proposals" or "Bids") for selection of a Service Provider through an open competitive bidding process in accordance with the procedure set out herein.
- 3.5. A detailed description of the objectives, scope of services and other requirements including the terms and conditions for providing services are specified in this RFQ. In case a Bidder possesses the requisite experience and capabilities required for undertaking the assignment, it may participate in the Selection Process in response to this invitation. The manner in which the Bid is required to be submitted, evaluated and accepted is explained in this RFQ.

- 3.6. The selected Bidder would be required to undertake the required works, in accordance with the agreement to be entered separately between the Authority and the selected Bidder (the **“Agreement”**).

#### 4. **OVERVIEW OF SELECTION PROCESS**

- 4.1. The Authority has adopted a 2 (two) stage selection process (collectively the **“Selection Process”**) for evaluating the Proposals. The evaluation of the bids will be done by the Technical and Financial Evaluation committees of the Authority.
- 4.2. In the first stage, the credentials of Bidders would be evaluated to assess their compliance as per the Evaluation criteria specified in Section 8.1 (**“Evaluation Criteria”**) and based on this evaluation, a list of technically qualified Bidders shall be prepared. The rest would be considered technically non-qualified and would not participate in the process.
- 4.3. In the second stage, a Financial Evaluation will be carried out as per criteria mentioned in Section 11 of this RFQ from the technically eligible Bidders for providing the services as mentioned in the Scope of Work. (**“Financial Evaluation”**).

#### 5. **INSTRUCTIONS TO THE BIDDERS**

- 5.1. Interested Bidder(s) are advised and encouraged to study this RFQ document carefully and inform themselves fully about the assignment before submitting their Proposals in response to the RFQ. Submission of a proposals in response to this RFQ document shall be deemed to have been made after careful study and examination of this document with full understanding of its terms, conditions and implications. Proposals must be made strictly in accordance with the terms and conditions specified in this RFQ.
- 5.2. The RFQ document has been made available for download at <https://www.the-aiff.com/documents>. Any corrigenda to the RFQ will also be available under the same section. The bidders are advised to regularly check the website for any corrigenda.
- 5.3. Any failure, oversight or delay to read any such addenda will not entitle any Bidder(s) to any additional time for submission of Bids or any other relief or create any liability in any manner of the Authority towards the Bidder(s).
- 5.4. The Bid should be unconditional. In case of any condition, the Bid shall be treated as non-responsive and may be disqualified.
- 5.5. The Bid should be only in the prescribed format as provided in Annexure III. It should also be accompanied by all the requisite supporting documents, else it may be rejected.

## 8. SUBMISSION OF PROPOSALS

The bidders are required to submit the proposals for the above-mentioned scope of work in the format provided in a **password protected PDF file**. The proposals for the above-mentioned services are to be submitted on bidder's letterhead signed by the Authorised Representative and submitted online via email to **tenders@india2022wwc.com** within the stipulated time frame. **Please state the Bid Reference No.: i.e. "LOC/FIFAU17WWC2022/RFQ/05" in the subject line of the email.**

## 9. Evaluation Criteria

The bidders are also required to submit the following documents to ascertain the technical compliance of the bidder. The proposals of only those bidders who are technically compliant with the below requirements will be considered.

Further, the Authority reserves the right to seek clarifications or more details as may be deemed appropriate. The following must be complied with:

9.1. The Financial Bids of only the Bidders who satisfy the above mentioned technical evaluation criteria will be opened and the bidder with the least cost will be preferred for appointment as Service Provider

## 11. VALIDTY AND MODIFICATION OF PROPOSAL

11.1. The Bids shall be valid for a period of 60 days from the date of evaluation of the Bids. A Bid valid for a shorter period may be rejected as non-responsive.

11.2. No Bid shall be modified, substituted, or withdrawn by the Bidder on or after the Bid Due Date.

11.3. Bidders are advised to exercise adequate care in quoting the prices. No excuse for corrections error will be entertained after the Bid Due Date has passed.

## 12. EVALUATION OF BIDS

The evaluation of the Financial Bids will be done by the Financial Evaluation Committee appointed by the Authority. The committee, during the time of evaluation, may seek clarification from the Bidder(s) on the amount quoted in the bid. **The lowest financial bid will be awarded the work.** The Authority reserves the right to negotiate with the lowest bidder in case the rates quoted by the lowest bidder are found unreasonable by the financial bid evaluation committee.

**13. LIQUIDATED DAMAGES FOR UNSATISFACTORY SERVICES**

13.1. The selected Bidder will ensure that all the services are being carried out as per Scope of Services section of this RFQ unless otherwise informed by the Authority. In the event of unsatisfactory quality of services by the successful Bidder, the Authority reserves the right to withhold the payments or make suitable deductions as necessary. The Authority may also look at alternative arrangements in case the selected bidders performance are not up to the mark.

**14. TERMS OF PAYMENT AND PAYMENT MILESTONES**

14.1. The Selected Bidder(s) will need to submit an invoice in hard & soft copy to the Authority. Upon verification of the invoice by the Authority, the payment will be released as per the payment terms mentioned in this RFQ document.

14.2. The payment to the selected bidders will be made as per the following schedule:

First Payment Milestone	50% of Value of Agreement within 15 days of signing of the Agreement
Second Payment Milestone	Balance Payment to be made within 30 days of completion of the Tournament.

14.3. The prices, once offered, must remain fixed and must not be subject to escalation for any reason whatsoever within the period of the validity of the Bid and the contract. An invoice submitted with an adjustable price quotation or conditional proposal may be rejected as non-responsive.

14.4. The Authority reserves the right to ask the Bidder to submit proof of payment against any of the taxes, duties, levies indicated within specified time frames.

**15. TERMS AND CONDITIONS**

15.1. It should be noted that entities which are controlled or owned, fully or in part, by the same individual or entity may not submit separate bids under this RFQ, either as separate Bidders or as part of the same consortium.

15.2. Any failure, oversight or delay to read any such addenda will not entitle any Bidder(s) to any additional time for submission of Bids or any other relief or any claims against the Authority

15.3. The selected Bidder shall ensure completion of services in accordance with the provisions of the scope of services mentioned in this document and the Agreement which will be entered into subsequently.

- 15.4. The issuance of this RFQ does not imply that the Authority is bound to select a Bidder or to appoint the selected Bidder for the Services and the Authority reserves the right to reject all or any of the Bids without assigning any reasons whatsoever.
- 15.5. The Authority also accepts no liability of any nature whether resulting from negligence or otherwise, howsoever caused, arising from reliance of any Bidder upon the statements contained in this RFQ.
- 15.6. - 15.7. The Bidder(s) must ensure that all its relevant employees, officers, affiliates, advisors and subcontractors, permanently treat as confidential any data gathered which may pertain to, or be incidental to, this RFQ, irrespective of whether the Bidder is subsequently awarded the Agreement. The undue use by any Bidder of confidential information related to the process may result in rejection of its bid.
- 15.8. The Bidder(s) shall not have a Conflict of Interest that may affect the Selection Process or the award of Services Agreement hereunder. Any Bidder found to have a Conflict of Interest shall be disqualified. For the purposes of this RFQ Conflict of Interest may refer to any situation where a person could improperly influence the performance of duties and responsibilities of the Authority and/or the Selected Bidder(s) by itself or through any other person, or result in a breach of public trust, or be calculated to further the private or commercial interest of any person or organisation.
- 15.9. The Authority may, in its sole discretion, extend the Bid Due Date at any point of time.
- 15.10. The Authority reserves the right to verify all statements, information and documents, submitted by the Bidder in response to the RFQ. Any such verification or the lack of such verification by the Authority to undertake such verification shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Authority thereunder.
- 15.11. All documents and other information provided by the Authority or submitted by a Bidder to the Authority shall remain or become the property of the Authority. Bidders are to treat all information as strictly confidential. The Authority will not return any Bid, or any information related thereto. All information collected, analysed, processed or in whatever manner provided by the Bidder to the Authority in relation to the assignment shall be the property of the Authority.

- 15.12. The Authority reserves the right to make inquiries with any of the clients listed by the Bidders in their previous experience record.
- 15.13. The Selected Bidder shall not at any time use All India Football Federation or FIFA trademark(s) or trade name(s) in any advertising or publicity. If the Selected Bidder is found violating this norm it will be considered an IP right violation.
- 15.14. The Selected Bidder will be responsible for welfare of its deployed staff and ensuring that all the equipment's being used are in perfect working conditions. The Authority will not be responsible for any of them.
- 15.15. The Selected Bidder will co-ordinate with the Authority for access to stadiums and prior to starting their duties The selected Bidder would also be required to submit progress reports to the authority specifying the execution status reaffirming that timelines decided by the Authority are met.
- 15.16. Notwithstanding anything contained in this RFQ, the Authority reserves the right to accept or reject any bid and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.

## **16. MISCELLANEOUS**

- 16.1. The Selection Process shall be governed by, and construed in accordance with, the laws of India and the courts in New Delhi shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Selection Process.
- 16.2. The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
  - 16.2.1. Suspend and/or cancel the Selection Process and/or amend and/or supplement the Selection Process or modify the dates or other terms and conditions relating thereto.
  - 16.2.2. Consult with any Bidder in order to receive clarification or further information.
  - 16.2.3. Retain any information and/or evidence submitted to the Authority by, on behalf of and/or in relation to any Bidder; and/or
  - 16.2.4. Independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any Bidder.
- 16.3. It shall be deemed that by submitting the proposal, the Bidder agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/or performance of any obligations hereunder, pursuant hereto and/or in connection herewith and waives

any and all rights and/or claims it may have in this respect, whether actual or contingent, whether present or future.

## ANNEXURE – II – SCOPE OF SERVICES

### Brief Outline

- The 'Community Engagement Program' is an engagement / entertainment area to be setup within the perimeter of the Host stadiums at dedicated zones as decided by the Authority to celebrate the beautiful game of football with an objective to create awareness about the women's football.
- The engagement / entertainment area will allow fans coming into the stadium a dedicated space to try their hand at fun football activities on match day and to soak in the once in a lifetime experience of the FIFA U-17 Women's World Cup India 2022.
- The aim is to actively engage children / spectators during the Tournament in a carnival like atmosphere that encourages young children to adopt football as part their daily lives.
- The successful bidder would be responsible for end-to-end management of the engagement areas across the host stadiums for the Tournament.

### Detailed scope of work for the successful bidder would include:

- Event Operations: The successful bidder will be responsible for planning, designing, implementing, staging, producing, coordinating, supervising, managing and executing all the activities (end to end) related to 'Community Engagement Program' across all the host stadiums as per the elements listed in Annexure IV
- Activities: The activities to be included in the concept should be as per the activities list by the Authority in this RFQ with reference images provided at Annexure IV. The unit rates to be quoted should be in the format of the financial bid as at Annexure III. The unit rates are to include all costs and no costs such as travel, lodging, boarding , food & beverage etc will be reimbursed to the successful bidder.
- Creative Development and Production: The successful bidder will be responsible for design & production of all creative elements such as the branding for the game area backdrops. All other artwork required for the event must conform to the Branding Guidelines applicable for the Tournament which will be shared with the successful bidder.
- Branding – The successful bidder would be required to do the branding for the proposed engagement areas as listed out in Annexure IV keeping in mind the official look and feel of the FIFA U-17 Women's World Cup India 2022.
- Football Based Activities – It will be the responsibility of the successful bidder to ensure all football- activities are under adequate supervision of a co-ordinator. This will be achieved by engaging and encouraging the children to participate and enjoy the game of football. The successful bidder would also ensure that all the activities are conducted with same consistency at each stadium across all the host cities.

- Face Painters: The selected bidder would make provision for face painters as stipulated in Annexure III. The bidder to deploy the face painters around the spectator entry gates and in the designated stands. The face painter is to draw/paint country flags or any other shapes or football related designs. The face painter to ensure no religious or politically motivated messages/shapes/symbols/designs are used. The bidder is to ensure paints used are chemical free and suitable to be used on the skin.
- Foosball Tables: The successful bidder would procure and setup foosball tables at identified locations in the concourse area of each stadium. The bidder is to ensure the tables are placed/fastened securely to an immovable structure.
- Manpower: The successful bidder will be responsible to manage manpower deployed for the activities including the volunteers. Furthermore, the successful bidder will appoint a 'Project Manager' who will be the single point of contact with the Authority and an 'Activities Coordinator' who will be responsible for seamless conduct of all the activities across all the stadiums.
- Infrastructure set up – The selected bidder will be responsible for setting up the 'engagement areas' at location as determined by the Authority for the successful conduct of the engagement program.
