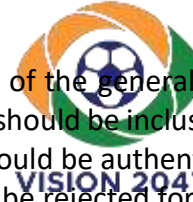
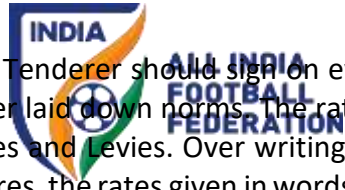

## CONDITIONS OF CONTRACT

1. Tender is open to the eligible Vendors/Firms of appropriate Class and skills. The technical requirement are as per attachment. The fixtures to be covered are also attached herewith for reference.
2. The Tender Applicant shall own the equipment mentioned herein as part of the technical requirement and proof of the same shall be submitted as part of the application process to this instant tender.
3. The intending tenders / vendor should apply in writing applying for the instant tender. The application would invariably be signed by the contractor himself / herself. The application shall be submitted for the work listed above with all required documents as indicated under. The applicants should enclose attested copies of the following along with the application –
  - (a) Latest Goods and Service Tax Clearance Certificate.
  - (b) Latest Income Tax Clearance Certificate as per the Indian Income Tax Act.
  - (c) Updated MSME Enlistment Certificate and Professional Tax Clearance Certificate.
4. The prescribed Non-Transferable Tender Documents (excluding the Tender Form) can be during the period specified as above from the office of the Accounts Department of the All India Football Federation, New Delhi.
5. The Tender Documents including the Tender Form with quoted offer should be placed in a sealed cover with the name of the Tenderers and the name of the work subscribed on it and titled “Application for tender for live broadcast of the Indian Women’s League Football Matches”. Supporting documents as required above should be enclosed with the offer.
6. Sealed tenders may be deposited in the Tender Box at the Reception Desk, **All India Football Federation, Football House, Sector 19, Phase 1, Dwarka, New Delhi – 110075**, on the date and within the time indicated above. The tender shall also be submitted online by the deadline at [production.tenders@the-aiff.com](mailto:production.tenders@the-aiff.com). Only Tender applicants who have submitted both online and offline submissions shall be considered for the instant tender allotment.
7. Tenders will be opened by a Tender Opening Committee constituted as prescribed by the AIFF.



8. The Tenderer should sign on every page of the Tender Documents as acceptance of the general direction and conditions of contract and other laid down norms. The rate quoted should be both in figures and words and should be inclusive of Goods and Service Tax and all other Taxes and Levies. Over writing and correction should be avoided and if made should be authenticated. In the incidence of discrepancy in figures, the rates given in words shall prevail. Incomplete/conditional tenders shall be rejected forthwith.
9. In case of any discrepancy in rate(s) printed in the Schedule of Rates and Quantities issued with the Tender Document, rates as per approved Schedule of Rates will be taken as correct. For items outside the Schedule of Rates the rates shall be as per the technically checked estimate/ analysis. Decision of AIFF shall be final. AIFF may ask for further clarification if required.
10. The Work value, scope and quantum of work are subject to change. The Vendor shall execute the work as per the directives of the department. No claim on this account shall be entertained whatsoever. If any extra claim is made, it shall be as per the agreement rates.

11. Avoidable damages due to negligence of the contractor shall be at his own risk and cost. The Department shall not be liable for payment of such damages (if any), including accidents to equipment/manpower at venue.
12. The tender offer shall remain valid for a period of 5 days.
13. All the conditions as mentioned in the Notice shall be deemed to be a part of the agreement to be entered with the contractor.
14. The Department reserves the right to accept/reject any or all tenders without assigning any reason thereof.
15. Subletting of contract work is against the norms and if it comes to the notice, the original contract shall be cancelled and appropriate action shall be initiated as per the rules.
16. In case the man power employed by the contractor is from outside the state or neighbouring countries, it shall be the responsibility of the contractor to get them registered with the Labour Department, Government of India, as per the relevant labour laws.
17. The department also reserves the right to increase, decrease, alter or modify the items of work as indicated in the Notice within assigning any reason thereof.
18. It is expected of the tenderer to have inspected the venue before submitting his bid and have their own correct assessment of the site before submitting the bid.
19. The contractor will have to pay all taxes and duties applicable and notified by the State/ Central Government and no claim shall be entertained in this regard whatsoever.

The Contractor will have to submit a detailed infrastructure declaration format of the setup they would use on the lines of the mentioned table alongside the financial details at the time of the submission of the bid.
