

NOTE ON FORMATION OF THE BODIES AS PER THE AIFF CONSTITUTION, 2025

A. AIFF NATIONAL COACHES ASSOCIATION (NCA)

The NCA is an independent body represented by football Coaches. However, it is not a separate legal entity and therefore has no authority to act on behalf of AIFF or to represent it towards any third parties. The NCA has no authority to legally bind or commit AIFF in any way. (Sch IV, Article 1.3)

I. Eligibility (Sch IV, Article 2.1)

Coaches must be minimum 18 years of age and should be a Licensed coach by the AIFF/FIFA.

II. Composition

- i. Office Bearers- (Sch IV, Article 2.2)
 - (a) Chairperson;
 - (b) Treasurer;
 - (c) Secretary
- ii. To be eligible to be an office-bearer at the NCA, a candidate must: (Sch IV, Article 2.3)
 - (a) Be at least 18 years of age at the time of election;
 - (b) Be a citizen of India;
 - (c) Be holding an AIFF/FIFA license under the category B, A or Pro if the Coach is a male and C, B, A or Pro if the Coach is a female;
 - (d) Never have received any sanction in relation to the World Anti-Doping Code;
 - (e) Never have been sanctioned for a breach (except for minor breaches and / or breaches not related to sports administration or a breach occurring with no fault or with a very light negligence) of the AIFF Constitution and its bye-laws, rules and Regulations.
- iii. A minimum of 1 (one) office bearer in the NCA Board shall be a woman. (Sch IV, Article 2.4)

iv. The **elections for the office bearers** of the NCA board shall be conducted by the **AIFF Election Committee.** (Sch IV, Article 2.5)

III. Term

- i. The length of the term of office bearers of the NCA board is 4 (four) years and a person shall not be eligible to hold office for more than 2 (two) terms. (Sch IV, Article 3)
- IV. Election Procedure for Coaches' Representative (Sch IV, Article 7)
- i. The NCA is responsible for electing 2 (two) Coaches (as defined in the AIFF Constitution) 1 male and 1 female, who shall be voting members of the General Body of AIFF.
- ii. The elected Coaches must be holding an AIFF/FIFA license under the category B, A or Pro if the Coach is a male and C, B, A or Pro if the Coach is a female.
- iii. A public notice shall be issued at least 30 (thirty) days prior to the AIFF General Body meeting where elections are to be conducted, calling for nominations from 'Coaches' Representative' so that elections for the posts of Coaches at the AIFF General Body can be conducted.

1.14 "Coach" shall mean any individual who performs duties relating to the training and selection of football players, as well as to tactical aspects of the game.
