A. AIFF NATIONAL REFEREES' ASSOCIATION (NRA)

The NRA is an independent body represented by football Referees. However, it is not a separate legal entity and therefore has no authority to act on behalf of AIFF or to represent it towards any third parties. The NRA has no authority to legally bind or commit AIFF in any way. (Sch IV, Article 1.3)

I. Eligibility (Sch IV, Article 2.1)

Referees must be minimum **18 years** of age and should be a registered Referee recognised by the AIFF/FIFA.

II. Composition

- i. Office Bearers- (Sch IV, Article 2.2)
 - (a) Chairperson;
 - (b) Treasurer;
 - (c) Secretary
- ii. To be eligible to be an office-bearer at the NRA, a candidate must: (Sch IV, Article 2.3)
 - (a) Be at least 18 years of age at the time of election;
 - (b) Be a citizen of India;
 - (c) Be at least registered to Level-5 qualification (FIFA/AIFF);
 - (d) Never have been sanctioned for a breach (except for minor breaches and / or breaches not related to sports administration or a breach occurring with no fault or with a very light negligence) of the AIFF Constitution and its bye-laws, rules and Regulations.
- iii. A minimum of 1 (one) office bearer in the NRA Board shall be a woman. (Sch IV, Article 2.4)

iv. The **elections for the office bearers** of the NRA board shall be conducted by the **AIFF Election Committee.** (Sch IV, Article 2.5)

III. Term

i. The length of the term of office bearers of the NRA board is 4 (four) years and a person shall not be eligible to hold office for more than 2 (two) terms. (Sch IV, Article 3)

IV. Election Procedure for Referee Representative (Sch IV, Article 7)

- i. The NRA is responsible for electing 2 (two) Referees (as defined in the AIFF Constitution) 1 male and 1 female, who shall be voting members of the General Body of AIFF.
- ii. The elected referees must be holding at least over Level-5 recognition as a referee from AIFF.
- iii. A public notice shall be issued at least 30 (thirty) days prior to the AIFF General Body meeting where elections are to be conducted, calling for nominations from 'Referee Representative' so that elections for the posts of Referees at the AIFF General Body can be conducted.

Relevant Definition-

1.47 "Referee" shall mean a person who has the full authority to enforce the Laws of the Game in connection with any Football match he or she has been appointed to officiate in.
